

Section 3 – External Auditor Report and Certificate 2019/20

In respect of MILLOM TOWN COUNCIL – CU0175

1 Respective responsibilities of the body and the auditor

This authority is responsible for ensuring that its financial management is adequate and effective and that it has a sound system of internal control. The authority prepares an Annual Governance and Accountability Return in accordance with *Proper Practices* which:

- summarises the accounting records for the year ended 31 March 2020; and
- confirms and provides assurance on those matters that are relevant to our duties and responsibilities as external auditors.

Our responsibility is to review Sections 1 and 2 of the Annual Governance and Accountability Return in accordance with guidance issued by the National Audit Office (NAO) on behalf of the Comptroller and Auditor General (see note below). Our work **does not** constitute an audit carried out in accordance with International Standards on Auditing (UK & Ireland) and **does not** provide the same level of assurance that such an audit would do.

2 External auditor report 2019/20

Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

The AGAR was not accurately completed before submission for review. Please ensure that amendments are corrected in the prior year comparatives when completing next year's AGAR:

- The smaller authority has not addressed the 'except for' matter raised by the external auditor when qualifying the prior year AGAR. The smaller authority has not restated the 2018/19 figures in Boxes 3 and 6, which included cancelled cheques. The figures in Boxes 3 and 6 for 2018/19 should read £14,369 and £72,135 respectively.
- Section 2, Box 7 for the prior year does not agree to Boxes 1+2+3-(4+5+6). The figure in Box 2 for 2018/19 is incorrect – it should read £102,410.
- Information received from the smaller authority indicates £248 of cancelled cheques have been included as income in Section 2, Box 3. These items should have been netted off from the relevant expenditure rather than shown as income. Box 3 for the current year should therefore read £51,152, and Box 6 should read £120,686.

Other matters not affecting our opinion which we draw to the attention of the authority:
